## Instructions for Installing *CDCynergy-SOC*

1. Insert the CD-ROM into your CD-ROM drive.
2. Click *Install CDCynergy-SOC to my hard drive*.
3. Click *OK* to save the program to your C:/ drive in the Program Files folder. You will see a dialogue box with the heading *Copying files, please wait...*

**Note to user:** You may select another drive to save the program by clicking the down arrow under *Drives*: Once you've chosen the appropriate drive, you may make a new folder by clicking *New*, typing in the new folder name and clicking *OK*. Then click *OK* again to start saving the program.

4. From now on, you will be able to run the program by double clicking the icon on your desktop labeled *CDCynergy-SOC*.
5. You will want to check your settings to be sure you can run the program fully; follow the instructions on page 4 of this Workbook. At the bottom of the opening page, click *Computer Settings Guide*. Follow the instructions on your screen. If you do not have an Internet connection, install any needed software from the CD-ROM by following the instructions on your screen. This will not work on Apple® computers.

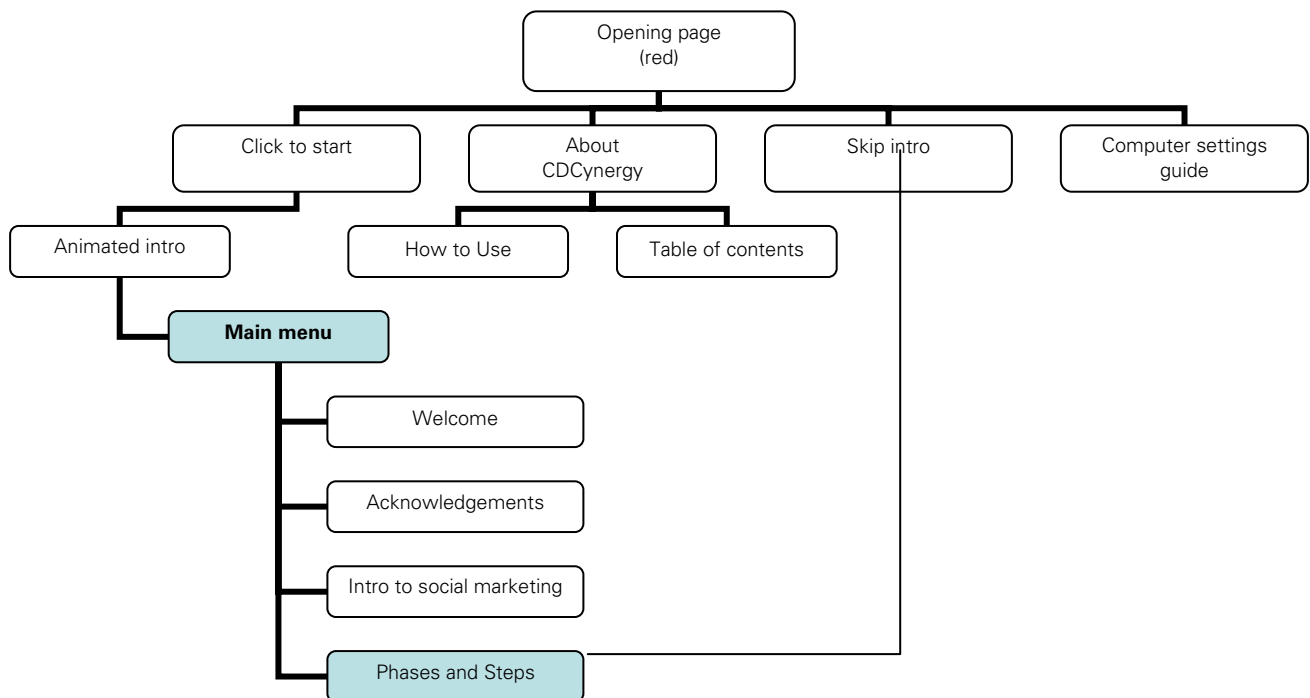
# Key Windows on the CD-ROM

## Exercise 1: Is Social Marketing for Me?

1. From the Introduction to Social Marketing window, click Is Social Marketing for You?
2. Follow slides 3-12, along with your trainer.
3. When prompted, find a partner and the group will count off in threes.
4. Work with your partner to complete the exercise below that corresponds with your number. Be prepared to walk the group through the slides and share your answers to the corresponding questions.

### #1: Maximizing Your Data

**Go to slide 13.** It asks you to consider, given this data, the type of behavior change program your agency might plan to influence target audience members to use condoms. Choose an option from slide 14 and enter your response here:

**Slide 15** contains another data point that reveals a little more about your target audience. If presented with both these data, a social marketing program planner would be prompted to ask the question on the slide: "Why?"

**Slides 16 and 17** contain more revealing data about target audience members who already use condoms and those who don't. Based on all the data you have now, what type of strategy would you suggest for the program?

**Read slide 18.** How does this reflect or compare with what you would have done?

How would you explain what it means to "Maximize Your Data?"

## **#2: Going Beneath the Surface**

**Go to slide 19.** Which picture do you think bothered members of a Native American target audience? Why?

**Read slide 20.** What, if anything, surprises you about the answer?

Social marketers and federal public health officials were working together on a campaign to influence working mothers to call to get information about state child health insurance programs. Slide 21 shows one picture they tested with target audience members.

**Read slides 21-23.** How could this concept of *Going Beneath the Surface* be important to apply to your current or recent behavior change project(s)?

**Be prepared to lead your classmates through the slides you've just viewed and share your responses.**

### **#3: Expanding the Toolbox**

**Go to slide 24. Read slides 24-28.** They discuss the impact of a knowledge campaign to prevent Sudden Infant Death Syndrome in the Netherlands and New Zealand.

**Read slides 29-31** for a discussion about why the Got Milk™ campaign was initially unsuccessful. The press release on slide 31 details the findings of milk producers' subsequent research. They found that strategies such as offering cross-product promotions (e.g., milk-and-donut promotions) and conveniently locating serving-sized containers of milk in stores significantly affected sales.

**Read slide 32.** How does the Got Milk™ campaign exemplify the concept of Expanding the Toolbox?

How could you use social marketing to expand the toolbox used in your current or recent behavior change project(s)?

**Be prepared to lead your classmates through the slides you've just viewed and share your responses.**

Step 4.2	Write specific, measurable objectives for each intervention activity.
Step 4.3	Write a program plan, including timeline and budget, for each intervention.

Step 4.3b	Develop or adapt a product.

Step 4.3c	Plan a strategy for policy change.
Step 4.3d	Plan communication intervention/promotion activities.
Step 4.4	Pretest, pilot test and revise as needed.
Step 4.5	Summarize your program plan and review the factors that can affect it.
Step 4.6	Confirm plans with stakeholders.
<b>Phase 5: Plan Program Monitoring and Evaluation</b>	
Step 5.1	Identify what information needs to be collected.
Step 5.2	Determine how the information will be gathered.
Step 5.3	Develop a data analysis and reporting plan.
<b>Phase 6: Implement the Interventions and Evaluation</b>	
Step 6.1	Prepare for launch.
Step 6.2	Execute and manage intervention components.
Step 6.3	Execute and manage the monitoring and evaluation plans.
Step 6.4	Modify intervention activities, as feedback indicates.
